All naming rights are subject to the **Terms and Conditions** as stipulated by the Hong Kong Breast Cancer Foundation from time to time.

Terms and Conditions

- The naming rights of the selected facilities, rooms and other physical assets of the Hong Kong Breast Cancer Foundation Jockey Club Breast Health Centre (Kowloon) (the "Kowloon Centre") (collectively "the assets") will be offered as recognition for donation of a specified sum as prescribed by the Hong Kong Breast Cancer Foundation (the "HKBCF") from time to time.
- All naming rights of the assets of the Kowloon Centre will have to be approved by the Management Committee of the HKBCF (the "Management Committee") before being offered to the respective donors. The Management Committee reserves the right to decline, modify or revoke any naming right of an asset as it deems fit.
- In approving the proposed name for an asset, consideration will be given to the appropriateness of the name as well as its consistency with the HKBCF's mission and purpose of the asset concerned. The Management Committee reserves the right to decline or revoke a naming right if in its absolute discretion, it considers there is perceived or actual possibility that the naming right may bring the HKBCF into disrepute or cause any undesirable impact.
- Where any naming right is declined, modified or revoked by the Management Committee, the relevant donation shall be allocated to other purposes, subject to mutual agreement between the HKBCF and the donor.
- The naming right of an asset is effective throughout but not beyond the useful life of the asset concerned the length of which shall be determined by the HKBCF in its absolute discretion.
- If the purpose of use of an asset changes after its naming right is awarded, the HKBCF reserves the right to alter the naming arrangement of the asset, in consultation with the donor as far as possible.
- All naming agreements entered between the donors and the HKBCF will be subject to modification or revocation of the naming right in case of any future occurrence which may disparage or impair the HKBCF's image, reputation or ability to pursue its mission. Any such future modification or revocation of the name of the asset concerned shall be decided by the Management Committee. The donors shall not, without the prior written consent of the HKBCF, assign, transfer, or otherwise deal with their naming rights hereunder.
- Each naming right will be reviewed carefully from time to time to ensure compliance with applicable laws of Hong Kong, including those related to prohibited gifts, and ethical principles.
- The HKBCF reserves the right to amend these terms and conditions at any time without prior notice.
